Allocations and Activities

1 The main Functions of the Parliament are:

- a. Undertake legislative functions;
- Review the activities of Ministries/Divisions by the Parliamentary Standing Committees (PSCs) and provide necessary counsel/recommendations/instructions;
- c. Inform concerned ministries/divisions about the assurances and commitments made by the Government in the Parliament as recorded in the parliamentary proceedings and monitor the progress of implementation;
- d. Taking consent of His Excellency the President on the Bills Passed by the Parliament and inform the Honourable Speaker and publish those laws in the Gazette;
- e. Execute activities related to International Parliamentary Convention and communication with Commonwealth Parliamentary Association (CPA), Inter-Parliamentary Union (IPU) and maintain liaise with different International Organisations; and
- f. Provide secretarial services to the parliamentary functions including all the other functions and taking arrangements of Audio Visual broadcast of parliamentary proceedings in order to confirm accountability and transparency.
